

HCS (Judicial) Examination Pattern

The HCS (Judicial) exam will consist of three stages i.e.

Stage 1 - Preliminary Exam

The Preliminary Examination shall be of objective type with multiple-choice questions as given below:

Paper/Subject	No of Ques.	Marks	Time
Main subjects of Law Current events of national and international importance, Indian legal and constitutional history and governance. Analytical skills and aptitude.	125	500	2 Hrs.

For wrong answer 0.20% i.e. 1/5th mark shall be deducted.

Stage 2 - Main Exam

The Main Examination shall consist of six papers five written and a viva voce. The description of papers and the syllabus shall be as under:

Paper Subject

I	Civil Law-I Code of Civil procedure, Punjab Courts Act, Indian Contract Act, the Indian Partnership Act, Sale of Goods Act, Specific Relief Act, and the Indian Evidence Act,	200 Marks	3 Hrs.
II	Civil Law-II Hindu Law, Mohammadan Law, and Customary Law, Law of Registration and Limitation	200 Marks	3 Hrs.
III	Criminal Law Indian Penal Code, Criminal Procedure Code and Indian Evidence Act	200 Marks	3Hrs.
IV	English English Essay (1000-1100 words) – 100 Marks Precis – 25 Marks Words and Phrases (Make sentences of the given words and Phrases) – 25 Marks Comprehension – 25 Marks Corrections – 25 Marks	100 Marks	3 Hrs.
V	Language Hindi (in Devnagri Script) Translation of an English passage into Hindi: 20 Explanation of Hindi passage in prose and poetry in the same language: 30 Composition (essay), idioms and corrections: 50	100 Marks	3 Hrs.

VI Viva Voca To judge the personal qualities of the candidates. The viva-voce shall relate to the matters of general interest and is intended to test the candidates' alertness, intelligence and general outlook. it shall be conducted in English.

Stage 3 - Vica Voca

Candidates thrice the number of posts in order of merit of Main Examination will be called for viva-voce.

- ◆ HCS (Judicial) Preliminary Exam Syllabus
HCS (Judicial) Exam will consist of questions from the Preliminary Examination shall be from the syllabus for the Main Examination.
- ◆ HCS (Judicial) Main Exam Syllabus
HCS (Judicial) main exam consists of questions from the main subjects of Law besides questions on current events of national and international importance, Indian legal and constitutional history and governance. The candidate shall also be tested for his analytical skills and aptitude. The standard of the question paper shall be of Law graduate level.
